Arani, Jalal H	Alexandria, Va. 22312	\$7,000	Works at MEK company, Axs Computer Company and personally contributed \$3,000. His wife and another relative contributed another \$4,000.
Choobin, Mohammad	Alexandria, Va. 22304	\$4,000	Works at MEK company, American Leading Technologies, and contributed \$1,000 under this name. Another \$3,000 was contributed under the names of Choobin, Neda and Choobin, Philip, also at American Leading Technologies.
Dehghan, Behjat	Alexandria, Va. 22315	\$3,000	Lists occupation as the Mehre Iran Farsi School in Burke, Va. (no telephone listing), but is well-known as the head of the MEK's women's organization.
Kiamanesh, Shahriar	Alexandria, Va. 22312	\$28,000	A well known MEK activist, Kiamanesh various lists his employer as American Leading Technologies, Phoenix Tour and Travel, and ICUSA - all MEK-related.
Mayelzadeh, Soheila	Alighoil. Falls Church, Va. 22044	\$1,000	Lists her occupation as "National Council Of Resistance."
Mostowfi, Hedayat	Annandale, Va. 22003	\$5,000	Mostowfi lists his occupation as "Business Owner," but is an employee of the NCR office in Washington, DC
Mshafiee, Abdolreza	Burke, Va. 22015	\$3,000	Lists his occupation as Phoenix Tour & Travel, an MEK company. (See Shafiee, Abdolreza, below)
Panah, Hossein	Burke, Va. 22015	\$3,500	A distinguished medical doctor, Panah has publicly lobbied members of Congress on behalf of the MEK and the NCR, using the name the Iranian Community of Virginia.
Rashidi, Abdolnaser	Falls Church, Va. 22042	\$500	Rashidi is a spokesman for the NCR in their Washington, DC office
Rassouli, Fazeleh	Burke, Va. 22015	\$3,000	Ms. Rassouli, who lists her occupation as "home-maker," frequently appears at pro-MEK demonstrations and rallies and is active in the women's organization
Roohi, Allen	Alexandria, Va. 22311	\$5,000	Works for MEK company, Axs Computer Corporation
Sepehrrad, Ramesh	Springfield, Va.	\$5,000	Identified by Iranian exiles and U.S. officials as MEK activist.

Shafiee, Abdolreza	Burke, Va. 22015	\$2,000	(See Mshafiee, above). Lists occupation as PTC Communications, another MEK company.
Zamani, Mansoureh	Herndon, Va. 22070	\$9,000	Principal of the MEK's Mehre Iran Farsi school in Burke, VA. Also lists her occupation as Zamco, possibly another MEK company.
